# COUDERSPORT BOROUGH COUNCIL REGULAR MONTHLY MEETING JULY 18, 2018 6:30 PM

The Coudersport Borough Council held its regular monthly meeting on Wednesday, July 18, 2018 at the Coudersport Borough Maintenance Facility on Damascus Street.

Council President George Hults called the meeting to order at 6:30 pm and led all present in the Pledge of Allegiance.

## **ROLL CALL**

## **VISITORS REQUESTS AND COMMENTS**

Christine Herzig invited everyone to come see the new pollinating garden at the arboretum. She shared that it has really taken off with all of the help of the volunteers watering it. There were 20 volunteers at the arboretum on Tuesday that worked on digging and weeding the gardens. Marty Maiuro has taken over the urns by the caboose and will remain taking care of them.

Robert Wagner expressed his concerns and opinions on the arboretum.

Robin Fink asked if Council is going to go through with the sale and if the Borough is going to pay for the Arboretums legal fees.

Wayne Wentzel asked if the Borough has a minimum bid set on the sale of the partial arboretum lot, and what will the Borough be doing with the money? Council Brian Ruane stated any fund will need to put towards the parks.

Lonnie Jo Hynds expressed her opinion on the arboretum.

Wayne Wentzel stated," We need to do what is best for the community".

Sandy Cramer was present to ask for the speed limit to be reduced on East Second Street by Sweden Valley Manor. There have been too many people killed in that area and she feels that traffic needs to be slower in that area.

### **ARBORETUM**

Solicitor Glassmire has accepted the invitation from Mr. Plummer to take a crack at preparing the proposed agreement of sale which would relate to the sale of the Arboretum. Solicitor Glassmire has not seen it until earlier today because of court and other things. Solicitor Glassmire stated "I have looked at it and there are some parts that are very standard, you would expect to see in an agreement of sale that is prepared by an attorney. There are a few things that I have concerns and questions." Solicitor Glassmire has been given a direction by council to have this project proceed and will need a little more time and should have it ready by next month's meeting.

### TRUCK BID

The Chevy 2005 truck bid was tabled from last month's meeting. The bids were received from D Gardino \$2,510, and Clyde Dheart \$1,600.
