An amendment to the Stormwater Management Ordinance No. 600 which regulates the rate and velocity of storm water discharge from proposed developments within the Borough of Coudersport and amends requirements for storm water retention and detention.

Development with less than (1) acre will require documentation of new impervious area in lieu of the 5,000sf currently requires.

Development with more than one (1) acre will require rate controls, volume controls and a Stormwater Management plan, in lieu of the 5000sf currently required.

2016 Fireman's Contract

They are asking for \$44,502.93, this is 1.35% of the assessed value. The options we have would be to raise taxes, use Act 13 funds or General funds to cover this. The Fire Company is willing to negotiate on the price. The Finance committee has met with Bryan Phelps and the committee has asked him for financial documentation. The 2015 contribution was in the amount of \$38,870.63
