COUDERSPOERT BOROUGH COUNCIL REGULAR MONTLY MEETING JUNE 16, 2023 5:00 PM

Coudersport Borough Council held their regular monthly meeting on Friday, June 16, 2023 at 5:00 pm at the Coudersport Borough Maintenance Facility on Damascus Road.

The meeting was called to order by Council President6 Wayne Hathaway who led all in the Pledge of Allegiance.

ROLL CALL

PENNSYLVANIA ECONOMY LEAGUE (PEL) PRESENTATION

The PEL was in attendance to provide Council their technical assistance and consulting findings through the Strategic Management Planning Program (STMP) that the borough has recently been going through. This is a grant that was obtained through DCED. PEL was hired to analyze the borough's demographics and financial history, review administration, public works, economic development, technology and labor: to project revenues and expenditures and compile recommendations for all areas. This presentation is not their final report as the final report will be more detailed and will also make recommendations to Council. These recommendations will also come with grant money (80/20) through DCED.

This presentation covered all aspects of Borough operations.

ENGINEERING PROPOSAL FOR STORM WATER PROJECT

A proposal from E & M Engineering was reviewed for the storm water project on Ross Glen that will utilize funding from the Local Share (Statewide) Grant that was received. The proposal cost is for \$35,000 with an additional cost of \$500 for each easement if the engineers prepare all necessary temporary or permanent easement documents.

PROPOERTY AND EQUIPMENT

The 1999 Kubota has been delivered to Joe Russell. No further information has been received as far as costs.

RECREATION/LIBRARY

There was an issue at the pool with the new stainless steel rails. Rust spots were found. Contractor was notified and company sent crew the next day to fix. Rust spots have been removed.
