COUDERPSORT BOROUGH COUNCIL REGULAR MONTHLY MEETING SEPTEMBER 15, 2023 5:45 PM

The Coudersport Borough Council held their regular monthly meeting on Friday, September 15, 2023 at 5:45 pm at the Coudersport Borough Maintenance Facility on Damascus Road.

The meeting was called to order by President Wayne Hathaway who led all present in the Pledge of Allegiance.

MEMBERS PRESENT

Present were Council members Wayne Hathaway, George Hults, Todd Husson, Marty Fry, Jack Keifer and Jesse Minor.

Also present were Mayor Andy Dubots, Manager Beverly Morris, Donna LeSchander (Leader Enterprise), Jen Sheehy, Atty. Karen Cahilly, Annie Maher, Kevin Maher and Teresa Kisiel.

ADDITIONAL AGENDA ITEMS

VETERAN'S WALL DONATION MONEY

It was motioned by Councilman Hults, seconded by Councilman Fry to add to the agenda discussion on the Veteran's Wall donation money. Motion unanimously carried.

REMOVAL OF TREE DEBRIS

It was motioned by Councilman Husson, seconded by Councilman Keifer to add to the agenda the disposal of a cut up tree to be removed from private property on South Main Street. Motion unanimously carried.

It was motioned by Councilman Fry, seconded by Councilman Husson to notify the property owner that the Borough is not in the position to remove cut up tree debris from private property but the tree remains can be hauled to the dump. Motion unanimously carried.

VISITORS REQUESTS AND COMMENTS

MAHER PROPERTY/ALLEY

Atty. Karen Cahilly, representing Kevin and Anne Maher of South Main Street, was present to resolve the old alley issue in the rear of their property. Atty. Cahilly states that there is no documentation of either a quit claim deed or an abandonment of the alley. The Maher's need to have this matter cleared up as they intend on selling their property. Atty. Cahilly would like to request consent from the Borough Council as a survey shows garage encroachment on the alley.

Manager Morris referenced a July 2000 Borough Council meeting minutes that reflect a motion, second and approval of Council to erect a fence using a minimum amount of the land that would be alley right

of way and to erect the fence in a temporary manner to enable relocation if the survey determined a different location.

Council tabled this matter until Solicitor Glassmire can be consulted.

25 EAST SEVENTH STREET

Teresa Kisiel was present to inform Council of a blight program that may be helpful at 25 East Seventh Street.

SURVIVOR FAMILY

Jen Sheehy was present to request that West Maple Street be blocked off from the fence at Dollar General to Vine Street on Saturday, October 28, 2023 from 3 pm - 10 pm for a Halloween maze. This maze is free of charge (donations accepted).
